

* Ontario Guideline No. 37: Craft services and food catering- **“Hair must be tied back, and/or in a hat, cap or net. Facial hair should be trimmed and clean.”**



* Ministry of Health and Long-Term Care S. 33 (1) (d) Every operator of a food premise shall ensure that every food handler in the food premise shall take reasonable precautions to ensure that food is not contaminated by hair; Operators are to ensure that every food handler in the food premise takes

reasonable precaution to ensure that food is not contaminated by hair. This may include the use of hair nets, baseball caps, visors and beard nets at the operator's discretion as long as the outcome is adequately protecting food from contamination.
